### **Description:**

**Medication Safety in the Geriatric Population

2. Identify age-related changes in older adults that can impact medication therapy.
3. Identify common red flags in geriatric medication regimens.
4. Assess a safety scenario/event and recommend a plan of action to improve medication safety.

**Pharmacy Law: Contraception & Women's Health**

4. Describe proposed legislation, including South Carolina's Pharmacy Access Act.

5. Discuss common conflicts at work and effective methods for conflict resolution, including the Thomas-Kilmann Conflict Mode instrument.
