# Pathway of the Prescription: Next Steps

This is a follow up session to the "Pathway of the Prescription" community forum. Presenters will identify the historical impact on current state and national strategies to improve safety, and increase knowledge of all health professionals on their role in the cultural change in opioid use. Gaps in knowledge regarding Opioid Epidemic, appropriate and safe use, storage, and destruction of medications will also be discussed.

- Review the history of opioid use and the impact of the current opioid epidemic in the U.S.
- ▶ Review national and state legislation to mitigate the opioid epidemic
- Assess resources available to health care practitioners to provide guidance in managing acute and chronic pain
