Pharmacy Law: REMS Programs

Medication Safety: Safety Considerations in Self-care

3. Obtain pertinent patient-specific information to identify vaccine needs or contraindications.

1. Describe the importance of tobacco cessation.
2. Define and describe tobacco cessation programs.
3. Identify barriers to quitting and triggers for relapse.
4. Compare and contrast available OTC treatment options for tobacco cessation.
5. Discuss safety issues with OTC treatment products.
