# **KEYNOTE SPEAKERS**



## Linda Bell, MD

Linda Bell received her undergraduate degree in molecular biology from the University of Texas at Austin, and obtained her medical degree from the University of Texas Southwestern at Dallas where she also completed residency training in Internal Medicine. Dr. Bell served as an Epidemic Intelligence Service Officer with the Centers for Disease Control and Prevention with both the Viral Special Pathogens Branch and as a field officer with the South Carolina Department of Health and Environmental Control (DHEC). Dr. Bell has held a number of positions with DHEC including, medical epidemiologist, Director of

the Division of Acute Disease Epidemiology and Director of Clinical Services. Dr. Bell is currently the South Carolina State Epidemiologist and Director of the DHEC Bureau of Communicable Disease Prevention and Control providing oversight for the Divisions of Acute Disease Epidemiology, Immunizations, Tuberculosis Control, STD/HIV and Surveillance and Technical Support.

#### Murray C. Penner, BSW

Murray Penner is Executive Director at NASTAD. He joined NASTAD in 2001. Prior to his current role, he served as NASTAD's Deputy Executive Director and the Care and Treatment Program Director. Mr. Penner oversees all NASTAD programs [including Health Care Access, Health Systems Integration, Health Equity, Prevention, Hepatitis, Global and Policy & Legislative Affairs] as well as NASTAD's overall operations. He has strong expertise and experience in HIV and hepatitis treatments, the Ryan White Program and AIDS Drug Assistance Program (ADAP), as well as drug pricing. Prior to his work at NASTAD, he served



as the Coordinator for the Fort Worth Area Ryan White HIV Planning Council. He received his bachelor's degree in social work from Bethel College and is pursuing his MPH from The George Washington University.



#### Joseph Williams, MSW, LGSW

Joseph Williams, also known as "The Misunderstood Social Worker," is from the District of Columbia and has over 16 years of experience in working with adjudicated youth, foster teens, and the LGBTQ Community as well as providing individual and group therapy to adolescents suffering from Oppositional Defiant Disorder, ADHD, Emotional Disturbances, and Bipolar I & II and Depression. Mr. Williams incorporates traditional, artistic, and out-of-box clinical approaches to treatment. He also maintains a Live Vlog on Facebook called *The Misunderstood Social Worker's Nightly Reflection* where he explores the concepts of "self love" and "healing for all people" through radical forms of psycho education and therapeutic exploration. His goal is to "help people one issue at a time."

## Eric Brenner, MD

Eric Brenner is a medical epidemiologist from Columbia with 40 years of experience working with disease control programs locally with DHEC, nationally with CDC, and globally with WHO. He attended UC Berkeley where he majored in French Literature, then worked for two years in the Peace Corps as a school teacher in the Ivory Coast (W. Africa), and later attended Dartmouth Medical School and completed training in Internal Medicine and Infectious Diseases. In 2015 he worked for CDC in the Ivory Coast to assist with preparations for possible introduction of Ebola, and earlier this year was again deployed to



Africa by CDC, this time to work on a plan to improve disease surveillance and response capabilities in Guinea. At the USC School of Public Health, he has long taught an annual course on "Infectious Disease Epidemiology." His interests focus on practical application of epidemiologic concepts, biostatistical methods and public domain computer tools to everyday problems encountered in communicable disease control programs.



## **Gloria Searson, MSW**

Gloria Searson is Founder and Executive Director for the Coalition On Positive Health Empowerment (COPE). COPE is committed to eliminating Hepatitis C through advocacy, education, patient screening, counseling, and peer support. Ms. Searson's 20+ years of advocacy efforts in the areas of HIV/AIDS, Hepatitis C and substance use earned her a place as one of the "Top Ten HCV Advocates of 2014" in *Hep Magazine*. As a national-level advocate, she has spoken before Congress and

at the White House. Gloria's educational background includes an undergraduate degree in political science from the University of Albany and a master's degree in social work from the State University of New York at Stony Brook.

# WHO SHOULD ATTEND

The SC HIV, STD and Viral Hepatitis Conference is designed for nurse practitioners, physician assistants, nurses, other clinicians, HIV/STD/Viral Hepatitis educators, social workers, case managers, public health professionals, pharmacists, other service providers, teachers, students, people living with HIV/AIDS and other interested community members. Our mission for this interdisciplinary conference is to provide opportunities for professionals and community members to engage in dialogue and share past successes, discuss current practices and interventions, as well as address emerging issues and trends.

# **CONTINUING EDUCATION CREDIT**
