Objectives:

Medication Safety: Error, Human Factors and Harm Workshop (9:10am - 11:10am) (ACPE UAN 0062-9999-20-027-L05-T, application-based activity, 2.0 live hours)

At the completion of this activity, the participant will be able to:

- Describe a framework for improving patient safety
- Identify elements of a culture of safety and models of error
- Discuss human factors and their impact on our daily actions
- Apply knowledge to a human factors exercise
- Assess a safety scenario/event and recommend a plan of action to improve medication safety
- Describe and practice skills in defining safe systems

Immunization Update 2020 (11:15am - 12:15pm) (ACPE UAN 0062-9999-20-028-L06-T, application-based activity, 1.0 live hour)

At the completion of this activity, the participant will be able to:

- Discuss the collective role of health care professionals in immunization practices
- Discuss and share recent activity of influenza within South Carolina and the nation
- Summarize recent changes to ACIP and CDC recommendations for adults
- Obtain patient-specific information to identify vaccine needs or contraindications

Law: The "Third Class" of Drugs (12:15pm - 1:15pm) (ACPE UAN 0062-9999-20-029-L03-T, knowledge-based activity, 1.0 live hour)

At the completion of this activity, the participant will be able to:

- Discuss regulatory and legal aspects of distribution of non-prescription drugs in the United States
- Define the "third class" of drugs and how this is practiced in other countries
- Identify current restrictions on the de facto third class of drugs, including pseudoephedrine, naloxone, emergency contraception, and vaccines
- Discuss practices and potential expansion of the de facto third class of drugs in the United States
